Under the direction of the Food Service Program Director, the Dishwasher is responsible for cleaning dishes at a professional level that meets sanitation standards, ensuring the kitchen has a steady supply of clean equipment. This person loads and unloads the dishwasher as needed. Assistance with meal preparation and serving is also required. - Cleans trash receptacles with water or steam.
- Moves dishwashing supplies and equipment from storage to work area by hand or using hand trucks.
- May assist in cleaning and preparing various foods for cooking and/or serving, as directed.
- Ensures work areas remain safe, clean, and orderly, adhering to all company, local, and state guidelines regarding health, safety, and sanitation.
- Performs other related duties as assigned.
